- 1) Harpenden Swimming Club is affiliated to Hertfordshire ASA & ASA East Region.
- 2) This Competition is licensed by the ASA for entry into Regional Competitions and will be held under ASA Laws and ASA Technical Rules.
- 3) Entries may only be accepted from competitors registered as members of the ASA, SASA or WASA or competitors from one of the countries affiliated to FINA.
- 4) The pool length is 50m and the pool has 8 lanes.
- 5) Age groups for boys and girls are single banded age groups from: 11 yrs to 16yrs and 17yrs & over.
- 6) Medals for top three in each age group for each event.
- 7) Age as at 31st December 2018
- 8) Heats will be swum with all ages combined and seeded on submitted times.
- 9) Once an entry has been accepted a competitor shall swim or give notice of withdrawal. **Notice of withdrawals** from a club shall be reported to the recorders at **least 20 minutes** before the start of the session. Late withdrawals will be charged a £10 fine.
- 10) All swimmers must be supervised by their coaches/team managers during warm up/swim down and whilst on poolside. Coaches/Team Managers are responsible for the behaviour of their swimmers at all times.
- 11) No responsibility will be accepted for any loss or damage to clothing or other articles.
- 12) Swimmers will not be allowed into the viewing gallery or cafeteria area in swimming costumes and footwear must be worn.
- 13) Only swimmers, officials and Team Managers/Coaches accredited with deck passes will be allowed on poolside.

ENTRIES

- 14) Valid entries will be accepted up to the closing date for the meet
(Midday Friday 23rd February 2018)
Entries will be accepted on a first come first served basis.
- 15) Complete entries for each club are requested together with a single payment. Later individual entries may not be accepted. **Closing date for entries is midday Friday 23rd February 2018.**



- 16) The entry fee is £6.00 per individual event All club entries with over 8 swimmers must be via Hy-Tek software. No entries will be accepted after the closing date or during the meet unless due to promoter's error or omission.

DECK PASSES

- 18) Deck passes are available for poolside access at £10 per pass. Clubs will be allowed passes at the following ratios
1 – 20 swimmers – 3 passes
20+ swimmers – 5 passes
Deck passes will not be sold on the day.

PHOTOGRAPHY & DATA PROTECTION

- 19) Photography on poolside or in changing/toilet areas is forbidden. Any person found to be contravening this policy will be asked to leave the gala without refund.
- 20) In accordance with the ASA Child Safeguarding Policies and Procedures any spectators, parents or carers who wish to take photographic or video images are requested to focus on their own child as much as reasonably possible and to avoid including other children in those images, particularly if those images are being shared with family and friends through social media platforms. Should you have any concerns about photography or filming at this event then please bring them to the attention of our Welfare Officer Yvonne Wimbleton or the promoter Bryan Thompson. Any person found to be contravening these policies will be asked to leave the gala without refund.
- 21) This event may be broadcast online. Any person entering the event will be deemed to have given consent for images to be broadcast.
- 22) Entries to this meet will be held on a computer and consent, as required by Data Protection Act 1998 (as Amended), to the holding of personal information on computer will be deemed to have been given by the submission of the entry.
- 23) Anything not covered in these conditions will be at the Promoter's discretion.
